Background Roughly 41 million people were eligible for Medicare benefits in 2002. HI, or Part A of Medicare, provides partial protection against the costs of inpatient hospital services, skilled nursing care, post-institutional home health care, and hospice care. SMI (Part B) covers most physician services, outpatient hospital care, home health care not covered by HI, and a variety of other medical services such as diagnostic tests, durable medical equipment, and so forth. Only about 22 percent of HI enrollees received some reimbursable covered services during 2002, since hospital stays and related care tend to be infrequent events even for the aged and disabled. In contrast, the vast majority of enrollees incur reimburs-able SMI costs because the covered services are more routine and the annual de-ductible for SMI is only 100. The two parts of Medicare are financed on totally different bases. HI costs are 1 met primarily through a portion of the FICA and SECA payroll taxes. Of the total FICA tax rate of 7. 65 - percent of covered earnings, payable by employees and em-ployers, each, HI receives 1. 45 - percent.
